# Annual Board Meeting a Virtual Success!



Parent/Child Incorporated's version of the State of the Union, called the **Annual Report to the Public -Pre and Post COVID-19, was a huge success!** Each Head Start agency is required to make available to the public a report published at least once in each fiscal year that discloses the following information from the recently concluded fiscal year which includes (A)The total amount of public and private funds received and the amount from each source; (B) An explanation of budgetary expenditures and the proposed budget for the fiscal year; (C) The total number of children and families served, the average monthly enrollment, and the percentage of eligible children served; (D) The results of the most recent review by the Secretary and the financial audit; (E)The percentage of enrolled children that received medical and dental exams;

(F) Information about parent involvement activities; (G)The agency's efforts to prepare children for kindergarten.

The presentation confirmed that PCI firmly believes in serving our children and families with **quality** and **integrity** and upholding the mission of PCI to empower our children, staff, and families to achieve success, resulting in loyalty to the PCI brand.

# Focus Area 2 and PCI's Self-Assessment

Upon return from Spring Break, PCI will have two exciting events occurring: 1) The Focus Area 2 Monitoring Review from the 15<sup>th</sup> through the 18<sup>th</sup>, and the annual Self -Assessment. Due to the Focus Area 2 Review, specific times for the training will be provided to you by Mr. Jesse Diaz. Head Start Program Performance Standards state that at least once each program year agencies must conduct a Self-Assessment of their effectiveness and progress in meeting program goals and objectives and in implementing Federal regulations. This must be done with the consultation and participation of the Policy Council, Board of Directors and as appropriate, community members. Some individuals may be interviewed, as will also take place with the FA2 Review, so do not be surprised or intimidated.



#### ChildSafe's Cardboard Kids® - Drawing Attention to The Issue of Child Abuse

Cardboard Kids Is a Child Abuse Prevention Campaign Happening in San Antonio and PCI is participating! In 2019, there were 5,867 confirmed cases of child abuse and neglect in Bexar County. And while that number is staggering, it's just as shocking to learn that only 1 in 10 sexually abused children ever report it, leaving 9 others to keep a terrible secret. For those 9 children, we must start the conversation.

In 2014, ChildSafe created Cardboard Kids, a city-wide public awareness campaign to draw attention to the pervasiveness of child abuse and the fact that every story is different and every child unique. Cardboard Kids are more than two-foot-tall cardboard figures. They represent one of the thousands of children that are abused and neglected at the hands of adults in our community each year. They start the conversation, not only by creating a visual symbol for children to identify with but also by providing valuable tips for caregivers on how to talk to their children about child abuse and neglect.

Cardboard Kids will begin distribution March 6 and 13. They will be decorated and placed all over San Antonio on "Reveal Day," Thursday, April 2, 2021. Let us all be a champion for those who have spoken up as well as for those who need a voice.

# **New Virtual Criteria Coming Soon!**



Though the criteria may change, the quality in teaching remains the same. As in prior years, there will be one nominee representing your center. Training Staff are working to assure the nomination criteria and procedures are doable and are followed. All nominees will go through a Zoom interview process.


# Message from the CDC - COVID-19 Vaccine

The U.S. Centers for Disease Control and Prevention (CDC) identifies the COVID-19 vaccine as one of the strategies to protect your health and prevent disease. Head Start and Early Head Start teachers and staff are critical to the continued functioning of their communities. They are also at potential occupational risk of exposure to COVID-19. To support staff and safe in-person learning, teachers, Head Start/Early Head Start, and childcare workers have been given high priority to receive the vaccine. Vaccinating teachers and staff is considered one layer of mitigation and protection for staff, children, and families. Please read more information below from the CDC regarding the COVID-19 Vaccine.

#### **Key Messages**

# You can help stop the pandemic by getting a COVID-19 vaccine.

To stop this pandemic, we need to use all our prevention tools. Vaccines are one of the most effective tools to protect your health and prevent disease. Vaccines work with your body's natural defenses so your body will be ready to fight the virus if you are exposed (also called 'immunity').





### COVID-19 vaccines are safe and effective

The U.S. vaccine safety system makes sure that all vaccines are as safe as possible. Learn how the federal government is working to ensure the <u>safety of COVID-19 vaccines</u>.

CDC has developed a new tool, <u>v-safe</u>, to help us quickly find any safety issues with COVID-19 vaccines. V-safe is a smartphone-based after-vaccination health checker for people who receive COVID-19 vaccines. Download the **v-safe** app after you are vaccinated!

Studies show that COVID-19 vaccines are very effective at keeping you from getting COVID-19. Experts also think that getting a COVID-19 vaccine may help keep you from getting seriously Ill even if you do get COVID-19. These vaccines cannot give you the disease.



#### COVID-19 vaccine will be free for you.

The federal government is providing the vaccine free of charge to people living in the United States. However, your vaccination provider may bill your insurance company, Medicaid, or Medicare for an administration fee.






After COVID-19 vaccination, you may have some side effects. These are normal signs that your body is building protection.

The side effects from COVID-19 vaccination may feel like flu and might even affect your ability to do daily activities. Most of these side effects should go away in a few days.

# You will still need to wear a mask and socially distance after getting each shot of the vaccine for now.


