PATH OUT OF THE PANDEMIC

PRESIDENT BIDEN'S COVID-19 ACTION PLAN

To help ensure the safety of students, families, and their communities, the President's plan includes requirements that teachers and staff at Head Start and Early Head Start programs, teachers and child and youth program personnel at the Department of Defense (DOD), and teachers and staff at Bureau of Indian Education-operated schools get vaccinated.

I have shared President Biden's plan with everyone in an email when this information first came out because it specifically stated Head Start and Early Head Start. Though President Biden's plan states staff have until January 2022, it is up to local agenices that receive government funds to determine if the need to take action is sooner than the January deadline.

You are vital to PCI's success, therefore the following was considered when making PCI's deadline sooner than January 2022:

- PCI's Employment & Wage Deduction Authorization Agreement
- Thanksgiving Break and Winter Break timeframes
- Staff recruitment and hiring time needed in the event staff choose not to get the vaccine
- The need for full enrollment and the child/staff ratio needed
- 2-week notice for resignations

Based on all of the above, 2-week notices must be submitted by November 1, 2021 and the last date for employment with PCI will be November 19, 2021 prior to the Thanksgiving break. The time needed to recruit and hire new staff is limited and we must have appropriate child/staff ratios. As an employer and the grantee receiving federal funds, we must do our do diligence to stay in compliance and have a plan of action in place.



If you have a **disability/medical related reason** that prevents you from getting the vaccine, please provide information from your health care provider stating such and share that with Human Resources. If you have a "sincerely held religious belief" please provide the following to Human Resources for discussion, review and assessment in order to make a final decision:

- Statements and explanations that discuss the nature and tenets of your beliefs and information about when, where, and how you follow the practice or belief
- Written religious materials describing the religious belief or practice
- Written statements or other documents from third parties, such as religious leaders, practitioners, or others with whom you have discussed your beliefs, or who have observed your past adherence

If you fit in either of the above exemption categories, please provide your information to HR today or no later than November 11, 2021.

PCI Ad hoc Grant Application

The "ad hoc" grants are awarded to fund innovative projects or programs supplemental above and beyond the provisions of the regular agency budget for resources, supplies, and other items. These internal supplemental grants help to enhance PCI children and staff experiences, support innovative ideas, and expand upon existing programs. Currently, there are three types of Ad hoc grants available. **Resource Grants** fund up to \$250, **Innovation Grants** can award up to \$500, and **TEAM grants** award projects up to \$1,500. Projects of particular interest are those that build partnerships, enhance the agency, and meet the Agency's Strategic Plan and School Readiness Goals. The grant also supports staff in providing grants for special projects. *Please note you can only apply for one of the above grants per project.*

Application Process:

To complete the application, please include:

- 1. Brief Cover Letter
- 2. A detailed "project" budget for which funding is sought
- 3. Project timeline
- 4. Answer questions as applicable
