

#### PRESIDENT BIDEN'S COVID-19 ACTION PLAN

The deadline for remaining employed with PCI due to not being fully vaccinated has passed. All two-week notices for resignations must be submitted to HR by **November 1, 2021**, with the last day of employment being November 19, 2021. Providing the two-week notice allows you to be rehired by PCI if the position is available and you have been fully vaccinated. There are very few staff that will need to be terminated, but just having one staff leaving is far too many. **We are a family!** We love all our employees and wish them well in their future endeavors. Remember, if you become fully vaccinated and wish to **come back** to PCI, we welcome you if the positions are available.


