Full Enrollment Initiative

Kudos to our Family Service workers for doing a great job in recruiting and enrolling families/children into Head Start and Early Head Start. But did you know we all are responsible for recruiting and putting the word out about our programs? Recruitment is everyone's business here at PCI. The Office of Head Start has begun a program that focuses on the importance of **full enrollment**. Find out from Ms. Lydia Almares, Mr. Gregory John or your supervisor how you can help with our child recruitment efforts. This means we are required to provide services to 100 percent of our funded enrollment and maintain an active waiting list at all times.

Each month, I provide the Office of Head Start with our enrollment numbers per center. If we are not 100% enrolled for four consecutive months and are considered Chronically Under enrolled, our grant could be recaptured, withheld, or the amount reduced. With any of these, a reduction in staff is inevitable. So, full enrollment is everyone's business.
