In observance of the upcoming Winter Break, please be advised that PCI staff will receive early payroll on **Friday**, **December 13**, **2024**, instead of the usual pay date of December 20, 2024. EZ Texting Sign-Up:

- ECCs and Family Service Workers: Kindly confirm that all <u>parents</u>, <u>guardians</u>, and <u>staff</u> members have enrolled in EZ Texting or have them sign up during drop off or pickup Monday, December 9, 2024.
- To sign up, simply text "JOIN" to (210) 226-6232 from a cell phone. You will receive a confirmation message reading: "Welcome to EZ Texting Alerts." It's that easy to stay connected.

Technology Security Guidelines for the Holidays: Before departing for the Christmas and New Year holidays, please follow these essential technology precautions to ensure the security and functionality of your devices:

- 1. **Sign Out, Do Not Shut Down:** Be sure to sign out of your computer rather than shutting it down. If you choose to shut it down, please note that signing back in may take longer due to necessary system updates.
- 2. **Power Strips:** If your computer, speakers, and other devices are connected to a shared power strip, please avoid turning off the power strip after signing out of your computer.
- 3. **Prevent Delays:** Failure to follow these guidelines could result in hardware malfunctions and a 24-hour delay in accessing your computer upon return, as critical updates will run automatically when the device is powered back on.

We appreciate your cooperation in these matters, as it will help ensure seamless communication and a smooth return to work after the holidays.
