Please keep the following procedures in mind if it becomes necessary to close the agency due to emergency conditions in the area:

Decision-Making

The CEO, Dr. Sharon Small, will decide to close Parent/Child Incorporated (PCI). Dr. Small will evaluate the actions of local school districts, particularly the Northside Independent School District when determining the best course of action.

Communication of Closure

Once Dr. Small determines that closing is in the agency's best interest, she will notify the agency's Executive Team. The Head Start/Early Head Start Coordinator will then communicate the closure details to the appropriate staff, including ECCs (Early Childhood Coordinators). ECCs will, in turn, inform center staff of the agency's closure. Family service workers and teachers will notify parents about the closure. Notification System

Makeup Days and Emergency Planning

If a closure is necessary, PCI will schedule makeup days. Parents are encouraged to develop an emergency plan for their children if the Early Learning Centers are closed, have a delayed start, or dismiss early.
