## 2026–2027 Continuation Refunding Applications Submitted

The **2026–2027 Continuation Refunding Applications** have been successfully submitted. Special thanks are extended to **Mrs. Natalie Diaz**, the **Policy Council** and **Board of Directors** for their timely approvals, and to the **Executive Staff and Cabinet** for their hard work and valuable input in finalizing the applications.

As a reminder, our **fiscal year** begins on **February 1** and concludes on **January 31** of each program year. Accordingly, an annual application must be submitted to the **Regional Office of the Administration for Children and Families** in **Dallas, Texas**.

I am pleased to share that all four applications were submitted ahead of the November 1, 2025 deadline.







#### Red Ribbon Week 2025 (October 27-31)

This year marked the **38th annual celebration of Red Ribbon Week**, inspired by the life and work of **DEA Special Agent Enrique "Kiki" Camarena**. Agent Camarena dedicated his life to making a difference by fighting illegal drugs. In 1985, while working undercover in Mexico, he was tragically kidnapped and killed by drug traffickers.

In response to his sacrifice, citizens in his hometown of **Calexico**, **California** began wearing red ribbons. In **1988**, **Congress officially designated the last week of October as Red Ribbon Week**. Today, over **100,000 schools and organizations across the United States** participate, spreading the vital message of living a **drug- and alcohol-free lifestyle**.
